An OSM sample taken on 5 June 2019 failed to comply with the permit. The Iron result was 10.6mg/l against a limit of 6mg/l.

The sample was taken at the same time that maintenance being carried out on the humus tanks. We understand that as a result there is to be a company wide review of brushing diverts.
