## **Schedule 2 – conditions to be amended**

2. The following conditions are amended as follows:

### Schedule1 – Specified Land

The licence relates to land at Raymond Way, Old Mill Lane Industrial Estate, Mansfield Woodhouse, Nottinghamshire NG19 9BG (hereinafter called 'the site') shown edged red on Drawing Reference: AB/07/08 received 6th May 2008 and attached to this licence.

### Paragraph 1.1.2 of Schedule 3 – Conditions Relating to this Licence

This licence shall only authorise the following waste management activities:

- a) depositing;
- b) keeping;
- c) sorting;
- d) screening; and,
- e) transferring.

of the controlled waste identified in **Condition Number 1.2.1** of this licence.

### Paragraph 4.2.3 of Schedule 3 – Conditions Relating to this Licence

Wastes shall only be unloaded for sorting and screening in designated areas as identified within the Working Plan.

### Paragraph 4.2.6 of Schedule 3 – Conditions Relating to this Licence

Processing of wastes at the site shall only consist of the sorting and screening of wastes into skips, containers or bays as identified within the Working Plan.

### Paragraph 5.1.1 of Schedule 3 – Conditions Relating to this Licence

Precautions shall be taken to prevent and control any dust emissions from the site. External conveyor belts shall be covered in a manner which prevents the escape of dust.

A record shall be kept in the site log book of all preventative and/or control precautions undertaken. (**see Condition 7.3.1**)

Paragraph 5.2.2 of Schedule 3 – Conditions Relating to this Licence

Precautions shall be taken to prevent windblown material escaping from the site. External conveyor belts shall be covered in a manner which prevents escape of litter.
