Introductory note

This introductory note does not form a part of the notice

The following notice gives notice of the variation of an environmental permit.

This variation was to remove all hazardous waste codes, 'R'/'D' codes, and annual throughput associated with that waste type. It retains the waste codes, 'R'/'D' codes, and annual throughput associated with the non-hazardous waste transfer station.

The land within the current site boundary was covered by 2 permits (EAWML 80035 later known as EPR/BP3292LH and EAWML 80034 later known as EPR/BP3291SE) prior to consolidation in 2012.

The schedules specify the changes made to the original permit.

We consider that in reaching our decision to vary the permit we have taken into account all relevant considerations and legal requirements. We are satisfied that the permit will ensure that a high level of protection is provided for the environment and human health and that the activities will not give rise to any significant pollution of the environment or harm to human health.

The following conditions are added following an Environment Agency initiated variation

3.4 Fire prevention

3.4.1 The operator shall take all appropriate measures to prevent fires on site and minimise the risk of pollution from them including, but not limited to, those specified in any approved fire prevention plan.

3.4.2 The operator shall:

(a) if notified by the Environment Agency that the activities are giving rise to a risk of fire, submit to the Environment Agency for approval within the period specified, a fire prevention plan which prevents fires and minimises the risk of pollution from fires;

(b) implement the fire prevention plan, from the date of approval, unless otherwise agreed in writing by the Environment Agency.
