We were informed that Yellowstone has entered into a merger with Marlin Environmental. The intention is that both companies will trade as a group but remain separate entities. For information I would remind you of the requirements of permit condition 4.2.4 and the overall need that the operator of a permitted activity has to be the permit holder.

Climate Adaption- It was confirmed to us the site had received the recent communication from the EA that highlighted of the need to ensure adaption to climate change is considered and included within the sites documented Environment Management System.

Permit Review- It was explained the EAs review remains ongoing, an initial tranche of oil treatment sites for review have been identified, Yellowstone was not included.

I was told that when making its review submission Yellowstone had identified some areas where it considered future improvements would be needed and has initiated a number of projects across the site. The site is also in active discussions with the sewerage undertaker to ensure appropriate improvements in the discharge, including 3rd party monitoring.

Tank Farm- A further new replacement tank has been recently installed. A project to look at the future tank requirements has commenced. I would ask that you include the CIRA guidance for bund construction within your project.

### Site walkover

IBC storage area – Waste on site <100 tonnes.

It was seen on site that in a row the containers 1 stack of IBCs were not straight. The framework of the bottom IBC was badly damaged and was causing the containers above to lean outwards. It is important that stored containers are fit for purpose and in a condition that allow safe storage.

CCS 3 – Storage of IBCs on top of broken IBC

The site tri-canter is being replaced / upgraded. The replaced plant is on order and due on site over the next few weeks. The plant will be located within the same part of the building but to reduce the pipework required positioned against the opposite wall.

Please keep me informed on when the new tri-canter is installed.

There was little processing activity on site at the time of the visit, the site was observed to be tidy and generally clean.

The site surfacing was in good condition.

The gates / fencing around the site in good order, I understand a new pedestrian access is being considered by the site offices.

No amenity issues identified.
